Call to Order 7 Mayor Hamilton called the meeting to order at 11:30AM 8 Pledge of Allegiance n. Mayor Hamilton called for the Pledge of Allegiance. 9 III. Roll Call 10 Present were Mayor Hamilton, Mayor Pro-tem Howe, Councilor Germscheid, Councilor May, 11 Councilor Welker. Also present was Village Clerk Terry Cordova. A full quorum was present. 12 IV. Approval of Agenda 13 Mayor Pro-tem Howe made the motion to approve the agenda as written .Councilor Welker seconded 14 the motion. Motion carried 4-0. 15 16 ٧. **Business** 1) New 17 A. Consider Approval of a Lease from Caterpillar to Replace a Grader 18 Mayor Hamilton explained that we had sent back the John Deere and because we were not 19 able to lease another one with John Deere Butch went out and got another one through 20 Caterpillar and at a cheaper rate. Mayor Pro-tm Howe made the motion to approve a lease 21 with Caterpillar for a grader. Councilor Welker seconded. Councilor Germscheid asked if 22 there was any way to place a magnet on the grader. Mayor Hamilton stated that is was 23 something we could look into. Motion Carried 4-0 24 B. Consider a contract between the Village of Angel Fire and the Mercer Group Mayor explained that after the meeting on the 19th that he had decided to start looking for an 25 26 interim administrator. The Mayor went on to say that he was put in touch with Gus Cordova 27 of the Mercer Group. Mr. Cordova told the Mayor that he had 4 people that we may want to 28 look at for this position .Mayor Hamilton went over the proposal. He knows we are in a 29 budget crunch and that it is a temporary deal. His usual rate is from \$15,000 to \$20,000 30 dollars but he is willing to do it for \$2,000. He will put the whole thing together, the interview 31 process, interview questions and help with the contract. Mayor Hamilton highlighted the areas 32 he felt the interim person would work on, HR and our finances. Those are the most critical 33 areas. There are two from New Mexico and two that are out of state. Gus would like to get 34 stared to try and get interviews set up for next week or the first week in January depending on 35 every ones schedule. We also need to decide if we want to go outside of the council for 36 interviewers. Mayor Pro-tem Howe made the motion to enter in to a search contract with the 37 Mercer Group seeking an interim village administrator. Councilor Welker seconded. 38 Councilor Germscheid has concerns that someone from the outside would not be able to grasp 39 what we do here in just 3 months. Mayor Hamilton added that we would have to limit what 40 they do and focus on two, possible three areas and the person will gather information to share 41 with the department heads and how things can be handled. We cannot afford to have someone 42 come in and for the first two months go around talking to the departments heads finding out 43 everything that they are doing. Mayor Hamilton would like to see someone focused on HR 44 and Finance. Councilor Germscheid would like to see the two local candidates be included in 45 the interview process. Councilor Germscheid asked about moving cost for candidates that are 46 out of town. Mayor Hamilton stated that the village would not be paying for any rent and 47 could possibly be paying for moving expense depending on the circumstances. Mayor Pro-48 tem Howe stated that there was not anyone local that has any current experience and he would 49 like to see what's out there. Councilor Welker agreed that someone from out of town would 50 come in with a clean slate .Mayor Hamilton said that this was only for the interim and that the 51 new council and Mayor would be picking the permanent administrator. Councilor May said 52 she felt that connections in Santa Fe and not bring someone in from out of town were 53 important to her. Councilor May asked were we got the Mercer Group from. Mayor Hamilton

stated that Lupita put us in contact with Gus Cordova who is part of the Mercer Group and

5	interviews.
